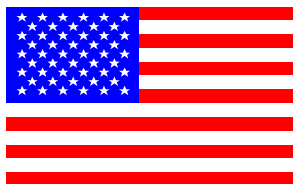

Costa Rica Gold 3-Peat

Diane Huntington Loring (1.3.4.2.5.11.3.1.3.2.1.2) represented Tae Ryong Taekwondo Ventura and the United States at the 7th Costa Rica Taekwondo Open in 2014.

Diane was honored for the third time, with an invitation to compete internationally by 6th Degree Black Belt, Master Jeffrey Anderson. Together they won at the 2011 Pan Am Open, 2014 Canadian Open, and now the 7th Costa Rica Taekwondo Open in 2014.

They won a Gold Medal in Black Belt Division for Poomsae Pairs (over 29 years). Diane also won a Gold Medal in Black Belt Division, Compulsory Poomsae/Forms (over 59 years).
